  - (d) Any and all actions, suits, proceedings, assessments, settlement, arbitration judgments, cost and expenses, including attorneys' fees, resulting from any of the matters set forth herein above.

- (e) the Distributor does not comply with all applicable legislations, statutes, ordinances, regulations, administrative rulings or requirements.
- (f) the Distributor remains inactive in business with Unifi AMC for a considerable period of time, as decided by Unifi AMC from time to time. Unifi MF also reserves the right to suspend brokerage under such cases.
- Further, Unifi AMC shall have the right to terminate the empanelment of the Distributor, without any cause, at any time by giving 30 (thirty) days notice to the Distributor. The Distributor may also terminate his engagement with Unifi AMC at any time by giving a 30 (thirty) days notice to Unifi AMC.

However, the Parties agree that following shall not be considered Confidential Information:

Becomes generally available to the public other than as a result of disclosure by the disclosing party or by the disclosing party's agents (in the case of distributors, including the sub-distributors), employees or representatives; or

Becomes generally available to the public other than as a result of disclosure by the disclosing party or by the disclosing party's agents (in the case of distributors, including the sub-distributors), employees or including the s representatives; or

Information which was previously known to the recipient

Information which was previously known to the recipient Party prior to receipt from the disclosing Party; or Information that is developed independently by the recipient Party or any of its employees, agents or representatives who had no access to the Confidential Information provided by the disclosing Party; or

Information which is disclosed to regulatory authority; or. Information which is disclosed pursuant to the requirement or request of a government agency or court of competent jurisdiction.

(b) Each Party further acknowledges and agrees

To protect Confidential Information, the standard of care required by the Party in protecting the confidentiality of Confidential Information shall be the same standard of care that the disclosing Party uses in protecting its own Confidential Information.
